

## STA International Legal Debt Recovery Costs / Charges Scotland

We try to restrict our costs to those which are recoverable from the debtor. In the event of success most if not all of the cost of our involvement will be paid for by the debtor. The recoverable costs cover all work in connection with the raising of court action, service of the court documentation and minuting for decree. If we are successful in recovering all monies due prior to decree, including expenses then the only charge to you is the VAT element of our fees which you can then recover from Customs and Excise.

#### Commission
